 - c) CB/23/03197/FULL Demolition of existing covered timber walkway. Retrospective approval for the existing single storey rear extension, erection of first floor rear extensions and double storey side extension at 3 Hill Crescent
 - d) Highways Act 1980 - S.26, S118 and S119 - Proposed Diversions, Creations and Extinguishments of Public Rights of Way which form a part of the restoration of the former Brogborough Landfill Site
